Please provide a copy of your insurance certificate with your entry and bring a valid insurance certificate, MOT test certificate and driving licences for all drivers with you on the day for checking.

All vehicles constructed or first registered more than 40 years ago and meeting the requirements of being a Vehicle of Historic Interest are now exempt from MOT testing. Consequently, we shall require documentary evidence of the roadworthiness of such vehicles either with your entry or at least two weeks prior to the event. This may be in the form of a valid voluntary MOT or a record of a roadworthiness inspection by a person competent to undertake such inspection in accordance with the relevant VOSA Inspection Manual.
